Area Description:

Writing Intensive (WI). Writing Intensive courses give students the opportunity to practice writing within particular contexts or disciplines. Writing instruction is a substantial, defining feature of the courses, which will be made apparent in lessons and feedback on the rhetoric, style, or content of written documents. Assignments will be guided by instruction on the process of writing through multiple drafts, addressing specific audiences, and achieving well-defined purposes.

Policy/Procedure

All UF undergraduate students are required to take 6 credit hours of approved General Education courses designated Writing Intensive (WI) in addition to the 6 hours of required Composition courses for a total of 12 hours, satisfying the rule established in Fla. Admin. Code R. 6A-10.030.

- To meet this requirement:
 - 1. At least 3 credits hours must be taken in courses relevant to student's major and 3 credit hours must be taken in the upper division (3000 or 4000 level).
 - 2. WI courses may not be taken S-U.
 - 3. The WI designation may be conferred concurrently with any other Gen Ed designation, except Composition, or by itself without another Gen Ed designation.
