Proposed Requirements

Response:

We are proposing to remove the thee courses (7 credits) within the DRT certificate program. This reduces the required credits from 21 to 14. The following courses are being requested to be removed from the curriculum:

OTH 6151 Applied Research in Driver Rehabilitation Therapy (4 credit hours) OTH 6152: Independent Study 1 for Research in Driver Rehabilitation Therapy (1 credit hour) OTH 6154: Independent Study 2 for Research in Driver Rehabilitation Therapy (2 credit hours)

We are also increasing OTH 6155 On-site Skills and Competency Training and Testing in Driving Rehabilitation Therapy from 2 credits to 3 and reducing OTH 6156 Seminars in Driving Rehabilitation Therapy from 3 credits to 2.

Impact on Program

Response:

We anticipate a positive impact on the program as noted in the rationale for the proposed changes.

Rationale for Proposed Change(s)

Response:

Feedback from the first cohort as well as experts in the field indicate that it is not necessary for students being prepared to be Driver Rehabilitation Specialists be required to conduct independent research. We do not anticipate any negative impact on the quality of the program. In fact, we anticipate an increase in enrollment by removing the research courses, thus reducing the number of credits needed to complete the program. The reduction from 21 to 14 is more appropriate for our professional certificate population (full time working professionals).

Assessment Data Review

Describe the Student Learning Outcome and/or program goal data that was reviewed to support the proposed changes.

Response:

A full program evaluation was completed following the graduation of the first cohort of the DRT professional students. The department critically examined the DRT program by collecting and analyzing information about the program's activities, characteristics, and outcomes. Data were collected from students, faculty and administrators directly involved in the program. The results allowed department administrators to make judgments about the program, improve its effectiveness, and inform programming decisions. Results from the evaluation indicated strong support for removing the research courses from the program. Students felt that they received

adequate knowledge about evidence-based assessment techniques from the program without the need for training on conducting independent research.
