Course Objectives The class is intended to provide a foundation of the US immigration law and the intricacies of the immigration law practice. This course will consider the historical and legal foundations of U.S. immigration law as well as key constitutional and process issues. It will address a number of areas of immigration law including immigrant and non immigrant visa classifications, roles of various federal agencies, grounds of inadmissibility, criminal immigration provisions, detention and removal, refugee and asylum, and U.S. citizenship.

After completing this course, students should be able to:

Describe the constitutional foundations of U.S. immigration law;

Demonstrate an understanding of the federal statutes and regulations that govern U.S. immigration law;

Demonstrate an understanding of the roles of the various agencies involved with the U.S. immigration law;

Explain an attorney's ethical obligations when representing individuals before USDHS and USDOJ; Determine basic strategy representation of prospective immigrants on the basis of family sponsorship and employment sponsorship

Determine strategic representation in defending noncitizens from deportation and representing refugees and asylum seekers
