Course Description An examination of the financial planning process, professional conduct and regulation, and education planning. Students analyze personal financial information, construct financial statements, develop financial strategies, and understand the components of a written financial plan.

Prerequisites FIN 3403

Co-requisites None

Rationale and Placement in Curriculum FIN 3124, FIN 4128, FIN 4132, and RMI 3011 cover the material required for a student to understand all aspects of wealth management and personal financial planning. Students must complete FIN 3403 (Business Finance) prior to taking this course.

FIN 3124 is the first course in the wealth management sequence. It offers a broad overview of the general principles of wealth management and personal financial planning, and then focuses on several specific topics, including the professional conduct and regulation of financial planners, education planning, and investment planning

Course Objectives Students will explore basic tools and techniques used in support of the financial planning process as well as the ethical, regulatory, and economic environment in which financial planners operate. Focus will also be on effective communication, ethics, professionalism, and attitudes towards risk. Additional topics include personal financial statements, budgeting, emergency fund planning, credit and debt management, buying vs. leasing, regulation of financial institutions, educational funding, financial planning for special circumstances such as divorce or disability, economic concepts such as supply and demand, and monetary policies.
