- 1) Remove the wording about 9 professional courses this unnecessarily confuses students and leads to many calls and emails to clarify
- 2) Add PUR3000 this has been on the internship application and we have considered it a requirement so the catalog is inconsistent with practice (a practice that predates my hiring 3 years ago)
- 3) Keep JOU3101
- 4) Add PUR3500 this is typically the third course for the 9 professional credits and spelling it out is clear for all
- 5) Keep 2.5 GPA
- 6) Remove the required approval from academic advisor and college this is not practice and also leads to confusion and wasted time with advisors
- 7) Keep Departmental approval I (the department chair) review each application and monitor their internships.
