Rationale and Placement in Curriculum FIN 3124, FIN 4128, FIN 4132, and RMI 3011 cover the material required for a student to understand all aspects of wealth management and personal financial planning.

#### CASE STUDY

For the Case Study, you will work in groups of 4-5 students and complete a comprehensive insurance case study. The details of the case study topics and requirements will be announced later in the semester.

#### MAKE-UP WORK
