Course Description Democratic decline across several counties and regions of the world. Addresses periods of democratic decline in regions in which democracy is expected, as well as in countries with histories of authoritarianism. Themes include Nazism, fascism, socialist and/or populist revolution, as well as democratic recovery in some cases.

Prerequisites CPO 2001 Introduction to Comparative Politics

Co-requisites None.

Rationale and Placement in Curriculum Course listings in CPO (Comparative Politics) currently do not include a course on democratic decline. Our current course availability tends to be arranged in regional clusters, as well as several important themes in Comparative Politics, including: democratization, political and economic development, post-industrial societies, authoritarianism, and ethnic conflict. The dangers in both old and new democracies for democratic decline is not currently addressed as a topic in itself; it is an important topic in the field. The course will be an elective. Course Objectives 1. Identify key points at which democracy begins to decline.

- 2. Recognize events that cause democratic decline or recovery.
- 3. Apply understanding of democratic decline or recovery to contemporary times in modern countries. **Course Textbook(s) and/or Other Assigned Reading** Selections from the Following Texts.
