 - The field of Biostatistics faces a shortage of domestic students. At UF, it could be possible to partly address this problem by encouraging students (domestic or international) from undergraduate programs at UF to complete a bachelors followed by an MS in Biostatistics. The bachelor's degree could be from any major provided that the listed prerequisites for the MS in Biostatistics program are met.

[The instructor uses one of the designated lecture meeting times for the class to hold "labs" in the FLG gymnasium, which he reserves with our building manager in advance of the semester. Email, 4/14/19]
- Please provide a description of the laboratory type exercises and components.
[This course is a strength and conditioning course, so some examples of "labs" include:
 - 1) Squat fundamentals. In that lab, mobile squat racks and bars are moved into the gymnasium and students work in groups to learn how to perform a safe squat exercise as well as assess the safety and effectiveness of someone else doing a squat (and how to properly cue safety and technique recommendations). Clearly, this is not ideal for a lecture hall setting.
 - 2) Dynamic warm-up. In that lab, students perform dynamic warm up exercises recommended for specific activities/sports. Students get the opportunity to experience the warm-up exercises as well as watch/assess other students performing them so they can better learn to evaluate the technique used.]
