# WELCOME

- 1. Approval of minutes of the September 16, 2019 meeting. Approved
- 2. Update from the Faculty Senate. Youssef Haddad relayed that a UF-Quest Resolution was presented as an information item during the Sept. Senate meeting. It was going to be presented on the Senate floor as an action item during the Oct. 17 meeting.
- 3. <u>Syllabus Policy Updates</u> Angela Lindner presented this informational item. The wording for the accessibility statement has been refined and modified, and will become the official language for the syllabus. The course evaluation section has been updated to reflect current

practices and students are encouraged to be productive in their feedback. The main syllabus page has not yet been updated online.

4. <u>University Of Florida Policy for Combination, Joint, and Dual Degrees</u>. Angela Lindner presented the draft policy and asked for volunteers for a subcommittee to assess impacts on current practices. This work was initiated due to Dr. Brophy's assessment of the current SACS assessment practices in an effort to address the overlap in credits in the programs and the need to justify them. Another issue that needs to be addressed is that there is no consistent naming across campus for these programs. Accordingly, this policy will define and name these programs in accordance with SACS. Historically there has been no single repository for all of these plans, as there have been creative collaborations outside of central control and approval.

To address this, in the upcoming year all existing and new programs need to come through the Approval system. It was noted that these programs should never delay graduation for our students and the practices need to be aligned.

The draft policy was begun in May, and in July internal conversations began across the university to assess the scope in regards to SACS COC accreditation. Meetings continued in September and October and it was agreed that the Approval system would be the best central depository.

A task force has been assembled to assess and address, with members across the breadth of the university, with consultations and conversations continuing across a number of units. The draft policy as presented should be considered a living document.

### Definitions

Combination Degrees: UF awards more than one degree from an overlapping coursework.

Dual Degrees: Students study at UF and at other institution(s). Each intuition awards a separate and unique credential but there can still be overlapping of some credits.

Joint Degrees: Similar to dual degrees, but only a single credential is issued, and has the seal of all institutions involved.

Justification of double-counted credits: these need to be justified for proper accreditation. The final report is due to the SACS COC in March 2020 and the university needs address this to avoid a flaw in our accreditation. Double-counted credits must be qualified as to not diminish either degree and provide a coherent area if study while protecting the integrity of undergraduate and graduate credentials. A certain number of double-counted credits are acceptable without justification.

The challenge when creating the form and Approval process is to make it comprehensive yet flexible enough for all programs and credentials, especially as approval will be required for all of these programs. Dr. Lindner went over bullet points in the PowerPoint presentation about the

details required for all degree combinations. Bachelors/Masters will be the initial focus with the goal of getting UCC approvals of the first submissions by the February meeting. At that point Dr. Brophy will be able to report to SACS COC that the process is in place and working.

The committee members were asked to volunteer for being members of task forces, to bring this information back to their colleges, and review the draft document and provide feedback. The policy itself will be sent to committee members. Accelerated degrees will also likely fall under this discussion. This topic will be revisited in November.

Approved.
- 11. <u>Proposed degree in B.S in Marine Sciences CALS, effective Summer B 2020</u>. See 10, above. Approved.
- 12. <u>Proposed changes to B.S Agricultural Operations Management major, effective Summer B</u> <u>2020</u>. Joel H Brendemuhl expressed a desire for a continuation of previous conversations. Recycled.

Joel H Brendemuhl announced that a couple of outstanding items were cleared up in advance of the meeting, including 8 semester tracking. An upper division GPA requirement was added as well, and Organic Chemistry will require at least a C within two attempts. Approved.
- 15. <u>Proposed changes to Organic Horticultural Systems specialization, effective Summer B 2020</u>. Joel H Brendemuhl reviewed items 15-17 together; all include name and curriculum changes and the number of specializations would be condensed from 4 to 3. New courses approved last year will be part of the updated programs. Approved.

Joel H Brendemuhl presented the fourth specialization that would be terminated to reduce from 4 to 3 specializations. Currently there are only 6 students in the specializations, and none of them were clear that they were in this specialization. Accordingly, it is believed that they can be moved without inconvenience. Approved.
- 19. <u>Proposed minor in Pathogenesis, effective Summer B 2020</u>. Joel H Brendemuhl presented. Some questions were addressed at the meeting, including the availability of the courses online and how they will apply for the minor. Approved.

Christopher Janelle relayed that some courses are not currently available online so some of the options are reduced from the residential version. Psychology has not yet confirmed that they have the online capacity for the changes so a discussion was requested with CLAS. Conditionally approved.
