WELCOME

Dr. Lindner welcomed everyone to this year's University Curriculum Meeting, and appreciated everyone's hard work in this capacity. Despite the pandemic, business goes on.

- 1. Approval of minutes of May 12, 2020 meeting. | Dr. Lindner presented. Approved.
- 2. Election of the Committee Co-Chair. | Dr. Lindner conducted the election. Youssef Haddad was not opposed to continuing in this role. The floor was open to nominations but Youssef was the only name in consideration and was elected.
- 3. Update from the Faculty Senate. | Dr. Haddad went over Academic Calendars; at the last meeting Homecoming was moved to Dec. 24. In spring also approved the CALS to rewrite CPM for 15 programs. This was an informational item and will be brought to a vote at the next meeting on Thursday.
- 4. Year in View for UCC. | Dr. Lindner discussed a PowerPoint presentation that covered the work of the committee and the expectations of what needs to be accomplished this year. Dr. Lindner recapped the past year in regards to the numbers per category. The approval rate displayed a philosophy as partnership with faculty members and trying to help departments accomplish what they wanted to accomplish.

Three major tasks that the committee will take on this year.

- Semester Plans with Quest 2 Requirement
- Combination (4/1) Degree Plans
- Engagement in Discussion of Implementing a Separate Professional Curriculum Committee

The Quest 2 requests will proceed per normal of the Approval process but no other changes to the 8 semester plans should be included. Any other changes to the 8 semester plans should be submitted in a separate submission.

Quest 1 is a prerequisite of Quest 2 and Quest 2 will be a prerequisite for Quest 3. Ideally 1000, 2000, and 3000 level. These must be submitted by February.

Andy Wolpert gave a recap of the Quest program to date and with the next catalog Quest 2 courses will be required. In Spring 2021 there will be 37 new Quest 2 courses. Currently most students are in What is the Good Life and not other Quest 1 courses, and this is expected to flip in Spring 20221 and going forward. Approval of Quest 2 courses continues with a deadline for October 2020 for new courses. An attribute in the SIS will mark appropriate courses as Quest to facilitate easier course discovery. Going forward the temporary courses will go through the normal Approval process to get the courses permanent prefixes and numbers.

The Combination Degree Plans need to account for all existing and any new are properly approved for accreditation by SACSCOC. These workflows have extra steps and so will take longer to process; accordingly, programs are encouraged to submit as soon as reasonably possible. Dr. Brophy added that these requests need to include the justification for any overlapping credits. Some were submitted this past March and when we hear back from this there could be some changes to what is required for proper accreditation.

Development of a Separate Professional Curriculum Committee is universally supported by all deans contacted. A task force of representatives from the professional colleges will be assembled to study the workings of the UCC. The goal is to have the PCC set up for Fall 2021 and would review and approve all items from professional schools.

Dr. Lindner concluded with going over the expectations of the UCC members. She stressed that the UCC members are a conduit back to their colleges and departments to ensure that they are involved in the curriculum approval process. A TEAMS page will be added for the committee to help facilitate online communications.

INFORMATION ITEMS

5. Proposed New Spring 2021 Schedule | Dr. Lindner said that Spring Break would move from mid-term to the beginning of the semester and extends the winter holiday break. Classes would start on Jan. 11 instead of Jan. 5, but classes will end as previously scheduled. This is primarily being done to facilitate safety both in the delay of start which could help deliver a vaccine and hopefully have the pandemic subside. Also, without Spring Break mid-term there will be fewer opportunities to bring Covid-19 back to the university. This is being done at several universities in the SEC as well as nationwide.

The committee reviewed a dates and deadlines chart for the Spring semester to show how some of the early dates would be affected. Right now the current calendar is in force but after the Faculty Senate votes but if approved by the Board of Governors then this could change in early October.

The communication plans will be very complete to ensure that all students know in advance. This plan also addresses some of the lost days in the Fall to mitigate overall teaching days. The university wants to avoid any long weekends to keep students from going elsewhere and coming back.
