Course Description Explores the broad field of education in a variety of traditional and nontraditional contexts. Introduces enduring issues in educational systems in the US and examines organizations and career fields focused on addressing these issues.

Prerequisites none

Rationale and Placement in Curriculum This is a required course in the Bachelor of Arts in Education Sciences major, and is also open to anyone interested in education-related careers or fields. It is designed to be taken as one of the first courses in the program so that students get a broad understanding of educational issues and organizations that address those issues.

Course Objectives

- Students will be able to identify two enduring issues in education systems in the US and outline major areas of contention in these complex problems. (Measured by discussion and participation in class)

- Students will investigate and then present an overview of one educational organizational (defined broadly) that is focused on addressing educational issues or training dilemmas. (Measured by presentation/project)

- Students will effectively communicate important aspects of their selected organization, including available data and stated impact. (Measured by Infographic assignment)

- Students will outline their career intentions and create a professional plan to achieve their goals. (measured by Professional Goal Statement)

Weekly Schedule of Topics This 1-credit course is an introductory course in the BAES Major, and has 3 main goals: 1) to introduce students to the broad field of education; 2) to introduce students to educational issues that are complex and challenging; and 3) to introduce students to various educational organizations that address those educational issues. Since this is a 1-credit class, some topics extend over several weeks to ensure adequate coverage. We do not see overlap with existing UF courses.

Incomplete Grades

An incomplete grade is described in the Undergraduate Catalog. It is the instructor's discretion as to

Attendance (Expected): There is a strong emphasis in this course on class discussions that will be informed by the readings. There are also presentations by guests and other students that cannot be made up if missed. Regular attendance is essential, and is tracked in Canvas weekly. Should you need to miss class for any reason, please let the instructor know prior to the session (via email). You are responsible for making-up all work missed during your absence. You can make up an excused absence by completing the regular work and a make-up assignment (see below in syllabus for further details) and handing it in no later than 1 week after your absence. Please make sure you have a fellow student take notes for you if you miss a class. Your assignment grade will be lowered by 10% if you do not complete a make-up assignment on time. 2. Article Submission: You will need to find and read a published article or news item relevant to any topic we've discussed in class. Please submit by email no later than one week after the absence you are making up. Late make-up assignments will NOT be accepted.

NOTE: there are no make-up assignments for unexcused absences. You will receive a zero for the day, and for any assignments you missed.

Homework/Readings and Participation (20%)

- Readings: Each week you should come to class having read (or watched) whatever has been assigned.
- Homework: There may be a short homework assignment on occasion - to be posted online.
- Participation: This course is dependent upon your active participation both in class and online. Two participation grades given per semester, based on daily preparation and homework completion.
- Attendance: You must attend class or follow the procedures below for excused absences. Attendance is marked each week.

Organization Presentation (40%)

- You will choose an educational organization for your project, either from a list I will provide, or of your own choosing with instructor approval. You will explore the purpose, mission/vision, and activities of this organization, along with possible opportunities for internships/volunteer experiences. You will interview a member of the organization, either by phone, in person, or via email, and include information from this interview in your presentation. Your presentation can be powerpoint, prezi, or another format with approval, to be uploaded in the canvas shell. You will have 10-12 minutes to share your presentation during one of the final weeks of class. Graded by rubric (available in canvas).

InfoGraphic (15%)

- You will create an InfoGraphic for the educational organization you selected for your project that communicates the essential aspects of the organization, including data, stakeholders affected, and impact (if possible). Graded by rubric (available in canvas).

Notes on Guest Speakers and Presentations (15%)

- You will take notes during all the guest speaker and student project presentations, and turn them in online, according to the due dates posted. Graded by rubric (available in canvas).

Professional Goal Statement (10%)

- The final assignment in the class will be to submit a one page professional goal statement outlining the professional areas of this BAES major that interest you and the steps you'd like to take during this program to achieve your career goals. Graded by rubric (available in canvas).
