#### a)

#### Active Learning Projects

Seven modules contain a globalization-oriented active learning project. These projects will require students to review the lectures, read the chapters, and analyze and apply the module key concepts. In some weeks, you will apply your learning by producing a teaching tool, such as creating a skit, poster or presentation. In other weeks, you will participate in a debate or produce a written report. You must complete 5 out of a possible 7 active learning projects (i.e., your two lowest scores will be dropped).

### b) Discussion Prompts

Eight modules contain a globalization-related discussion prompt usually related to the active learning project and each student must contribute an argument in response to the prompt and write reactions to two other students in the online discussion by the close of the module. You must complete 6 out of 7 discussion prompts in the course (i.e., you lowest score will be dropped).

#### c) Globalization Glossary and Quizzes

Each week students will be asked to define several keywords from the textbook and other course materials and record them in your globalization glossary. The glossary will act as your study guide for three reading quizzes over the semester, each of which represents 10% of your grade.
