# **WELCOME**

Dr. Lindner welcomed the members and went over the accomplishments of the past year including a new major in Data Science, upper division tracking, Quest 1, new academic policies, and dealing with an international pandemic by instituting the first UCC virtual meetings in the history of the university.

She returned to the focus on curriculum as discussed in the first meeting of the year and remarked that the committee has been true to the root of the word and kept curriculum moving forward. Curriculum at the university is alive and well and Dr. Lindner thanked the committee for their work in ensuring this. She also thanked the curriculum review subcommittee to enable smoother meetings, Youssef Haddad in his capacity as co-chair, the Registrar team who has helped the curriculum implementation and the keeping the UCC meeting running smoothly, and Casey, who Dr. Linder cited as the heart of the process.

Dr. Lindner also wished everyone to be well over the summer.

- 2. Update from the Faculty Senate. Youssef Haddad. The senate approved a proposal for the BS in Tourism, Event and Recreation Management to be renamed as Tourism, Hospitality and Event Management which previously passed the UCC. Youssef had asked that he could step down as co-chair to focus more on the curriculum in his department, but he noted that noted that things had recently changed a bit and that he would be happy to continue to serve in both capacities. Dr. Lindner thanked him for his service.

Dr. Baker presented this proposal which has been before the UCC previously; Dr. Brendemuhl has been involved in communications between all interested parties and they have come up with an adjusted name which is expected to be more acceptable.

The previous concern was the use of the term "geospatial" and so the new proposed name includes "geomatic sciences" instead. Accordingly, the new proposal is for SFRC to be renamed to the School of Forest, Fisheries, and Geomatic Sciences.

- Request to increase credit hours of DAN3775 from 2 to 3 credit hours is on this agenda. Approval of this certificate is contingent on approval of this course request.
  - The description does not appear to represent the current catalog. The first paragraph is rewritten to completely change the audience of this certificate.
     But it is not reflected in the marked-up copy. [The change in description has been reflected in the marked-up copy. Email, 5/7/2020]
    - Due to the different audience, more than half of the certificate is changing and a more detailed justification is needed. Please update justification/rationale for change to provide more detail regarding the modification to audience for certificate. [The rationale for changing the curriculum is due to curriculum changes that are occurring in the School of Theatre and Dance. The proposed revision focuses less on dance proficiency and more on professional development and career readiness specifically, how to utilize dance to support and promote well-being. In addition, the proposed revision will enable more non-dance major students to complete the certificate. The number of pre-req credits that non-dance majors must complete before starting the certificate can range from 2-5. Students will gain the skills necessary to facilitate practice in healthcare and community settings through completing the Dance in Medicine and Practicum courses. Introduction to Arts in Medicine in a Global Context will provide students with a basic understanding and overview of the field of arts in health. The studio course and Dance Appreciation or Dance Fundamentals courses will provide students with an adequate foundation in dance to meet the skills necessary for the certificate.]
    - How many courses satisfy the requirements for the Dance degree program are now part of the proposed changes? [Up to 2 courses, 5-6 credits depending on technique course selected. If a student chooses to take DAA1000 rather than DAN2100, it would be 1 course, 2-3 credits.]
  - How will learning objectives be met as this certificate is being modified to allow for beginner dancers as well as more advanced? [The learning objectives do not require significant changes although modifications were provided. The current and modified SLOs are not based on the level of dance proficiency and can still be met with this revision.]
  - A separate request for assessment changes will need to be submitted.

- NOTE: The total credit hours for this certificate changes from 14 to 13-14 unless the DAN3775 course is approved to increase from 2 to 3 credit hours (on this agenda). [The Dance in Medicine certificate will actually be variable credit no matter what, since dance technique courses vary from 2 to 3 credits depending on course. So, if the revision to Dance in Medicine passes, the certificate will be 13-14 credits. If it doesn't pass, the certificate will be 12-14 credits. Email, 5/11/2020]

- Course objectives note this course is possibly replacing a student's senior design course. For what major(s)? Is curriculum revision needed for this? Will this substitution be noted in the catalog, if so a curriculum change request will need to be submitted.

- Week 1 is on a Saturday, what is the purpose for this? Is this standard in the dept? A team-building workshop is held on the first Saturday to ensure the availability of speakers and extra time to start off the teams. Students with valid excuses will be accommodated.
  - Are the 6.5 hours of contact time worked into the total in order to equate to 3 credit hours? [It is included because in the first week they do not have any work to do at home so they will not exceed the total 9-10hrs of work per week for a 3cr class.]
- Please provide additional information regarding the assessments? E.g., what is a door code assignment and why is it listed but not graded? Are there points for attendance? [Attendance to activities is worth 5%. The door code exercises and training are safety trainings required before access to the lab is granted. They are not reflected in the grade. The grading scheme has been updated with more details about the assignments.]

    - If most students are taking BSC 2010, and either BSC 2005 or BSC 2010 are sufficient prereqs, the department should set the prereq as "BSC 2005 or BSC 2010". If there are any other courses that are considered equivalent, please list them by course number. [I have changed the prereqs to say BSC 2005 or BSC 2010. Email, 5/7/2020]
    - Syllabus lists "suggested readings" but from the weekly schedule in syllabus, it appears these are required. Please clarify.
      - Required readings include American Bee Journals by one of the course faculty. Are these freely available to students through the library or another (freely available) source?[Changed the wording in the syllabus to say required readings instead of suggested readings. The textbook can be accessed through the libraries or the students can purchase the book. The American Bee Journal articles are all provided to the students within each module.]

- Syllabus assignment—field experience—Do students who live in Gainesville have to ask for permission from the instructor and demonstrate a "legitimate" conflict in order to shadow a beekeeper rather than complete one of the other 2 options? [No, students do not need to ask permission from the instructor or demonstrate a conflict in order to shadow a beekeeper. Several students each semester live outside of Gainesville and so this option is primarily for them, but I haven't prevented any Gainesville-based students from shadowing a beekeeper. At the time this syllabus was submitted to the CALS CC, I wasn't sure what the situation would be concerning the COVID-19 pandemic. However, I have significantly changed this assignment for the present time to watching various beekeeping videos online and writing a report based on what they've learned. I have explained this in greater detail in the syllabus.]
- The appears the module assessments open after each section ends. Does this mean the students can start each module assessment for the subsequent section once the previous section finishes?
  - Will these instructions be clear to the students?
  - Recommend making this clearer for students.
  - [Within each module there is an associated assessment. The students can access the next module as soon as the previous module closes. This is not a go at your own pace course. Under Module Assessments in the syllabus it says in bold "The assessments 1) open the Saturday morning after the previous module ends, 2) are timed (60 minutes each), and 3) are due at 11:59 pm on the date listed in the course schedule".]
- Late submission of the field experience paper says points are deducted for late submissions regardless of the excuse. This is not compliant with UF attendance/make-up policy. It also conflicts with the statement in the syllabus that attendance/make-up is per the UF policy with the link included. Please update. [That was an error on my part and I have removed the words "regardless of the excuse" from the syllabus.]
- Points in grid re: peer review of beekeeping paper do not match with the description. Description says 40 points of the paper are based on peer reviews and 10 are based on instructor/TA grade. There are concerns about the fact that a student's paper grade is based on the grade assigned by another student in the peer review (students earn up to 40 points based on the grades their classmates give them).
  - Is this assignment team based? Is the peer evaluation regarding group effort/work?
  - Please provide more detail regarding peer evaluations, how they are conducted, and how the grading is derived.
  - [I can see how this would be confusing and I have reworded the syllabus for clarity. I ask the students to peer review one another's reports and assign a grade, which I have told them I would combine for a large portion

- of their grade. However, I always grade the reports myself and use the student reviews a guide, but never the final word on their grade. I have changed the wording in the syllabus to reflect this and hopefully prevent students from worrying that other students will determine a large portion of their grade.]
- Schedule grid in syllabus says there is an RSVP requirement but the description of assessments says 5 points for RSVP and sting quiz (sting quiz not mentioned in schedule grid). What is a sting quiz? [The Beekeeping experience RSVP and Sting Quiz are the same assignment. It is a short quiz that will allow me to ask what they are planning in terms of the Beekeeping Experience as well as an opportunity to make sure they understand the safety requirements when working with honey bees. However, because of the change caused by COVID-19, the students will not be meeting together for a Field Day event or shadowing beekeepers. I have removed this requirement and I will incorporate the sting quiz question into one of the module assessments.]

    - The proposal is to change course level from 4000 to 3000-level, change course prefix, change course title, change course description, change prereq. In looking at the old and new syllabi, the new course objectives appear to be more professionally based (consistent with the revised course description). Based on these changes and the rationale, this may need to be a new course request as opposed to modify. [This course is playing a similar role as it did under its previous name, but due to overall changes in the curriculum, the changes in course prefix, number, and description more clearly and logically place it in the revised course category. It's more of a fine tuning of the course and its role, rather than a completely new role that would call for the deletion of the former course, and creation of a new one. Email update, 5/8/2020]
    - UCC form says no request to change course number, but department is changing from 4000 level to 3000 level course—which means course number will change. Please clarify. [This has been updated to "no" on the UCC form.]
    - What is the desired outcome for this request rather than creating a "new" course request to make a new course? [The existing course has always included the "job hunting preparation" that we're continuing to include (resumes, cover letters, interview skills, etc.) and professional ethics. The larger intent of the course remains the same prepare students for professional success in a field-based natural resources/conservation career.]

- Can instructor provide examples of readings? "Who Moved My Cheese" is listed in revised syllabus as a possible reading but no other readings or sources are specified. [The "Textbooks" section has been updated in the attached syllabus.]
- Be sure late assignment penalty is consistent with UF policy that's linked in the syllabus (e.g. not accepted if late, unless late submission is excused).
   [Additional verbiage has been added regarding late assignments in the attached syllabus.]
- How are discussions/attendance assessed? [The attached syllabus has been updated to clarify that this portion of the grade is based solely on attendance.]
- Won't the pre-requisites of 3AG-FRC and 3AG-NRC suffice, as opposed to including 4AG-FRC and 4AG-NRC?
