**c. COMPASS Student Information Systems** – Updates from David Gruber Associate CIO and Senior Director, Enterprise Systems and Project Management Organization, Dr. Tammy Aagard, Associate Vice President for Enrollment Management –

1. **Screening Outcome** - Over 61,000 emails will be sent out to kick off the screening process
  - a. Pilot Kick Off email sent to 924 recipients on 07/01/2020
  - b. There were 306 emails invitation sent on 7/22/2020
  - c. There were 1,785 emails sent on 07/06/2020
  - d. Providing a 60% open rate
2. If additional assessment required, Health Services will reach out
3. Clinical will be tested in mid. August and given priority
4. Students will be given priority if they feel they need a test when living in dorm

**III. Waitlist Feature for Registration** – Angela Lindner/All

- a. Survey to gather information for each college to make consensus across campus
  - i. How do we prioritize filling seats?
    1. Floor: Waitlist functionality, units are already doing waitlist via pen/paper and very good for data. Waitlist multi-dimensional,

that could be manipulated by departments. Flexible process to allow departments to designate

2. All courses or opt out function for courses that don't need it. Drop down box and check various functions to apply to their wait list. Grater priority to students who have over 100 credit hours.
3. In favor of a service. Waitlist being configured the same way so it doesn't confuse students.
4. Most advisors are in favor of the waitlists
