Revise Master of Science in Teaching Mathematics SLO 3 Professional Behavior starting with the 2015-2016 assessment year. Proposed revised language: Prepares for lessons; arrives on time; conducts themselves appropriately. This language would replace the current language: Addresses students respectfully and develops and applies uniform grading processes. The assessment method would be unchanged: rubric scoring of classroom observation by member of supervisory committee and assessment of portfolio by supervisory committee. The new language addresses multiple observable professional behaviors which include respectful treatment of students. The actual grading is not observable, but construction of rubrics for grading has served as a proxy. It adds a professional development component which will be



assessed through the portfolio. The classroom observation rubric is included in the Academic Assessment Plan.
