Rationale/justification for the revision-

The College of Dentistry previous SLO 1 and SLO 2 utilized National Board Dental Examination and Florida license pass rates. While these measures are necessary for practice upon graduation they are not an outcome measure developed and conducted in the DMD curricular program. SLO 3 was a tracking outcome that students were completing all of the program competency assessments needed for graduation.

The SLO modifications requested are more consistent with the intent of SLO's to measure student outcomes within the academic program.
