Modification: Students will complete and successfully defend a dissertation within six (rather than five) years of entry into the program.

Rationale: Our students work as TAs or graduate teachers. Hence, six years until completion of the PhD is more realistic than five years. This also aligns with the assessment method in the Sociology program.

Modification: Students will not be required to present empirical research at a professional conference annually but only before graduating.

Rationale: Incoming students are not in a position to present empirical research at a professional conference at the beginning of their graduate school career.
