### A. Mission

#### **Graduate Program**

Sociologists conduct research about the social forces that shape all of our lives, often in hopes of improving everyday life and the life chances of each person. The Ph.D. program in Sociology provides the skills to organize information, communicate analytical research to academic and lay audiences, and prepare well-reasoned and carefully-written reports and documents that contribute to societal well-being. Our award-winning and internationally-known faculty successfully mentor graduate students to become established in their professional academic and nonacademic careers.

#### College

The principle mission of the College of Liberal Arts and Sciences (CLAS) is to lead the academic quest to understand our place in the universe, and to help shape our society and environment. Through teaching, research and service, CLAS continually expands our knowledge and practice in the most fundamental questions in the arts, humanities, social sciences, and natural and mathematical sciences. At the graduate level, students master a specialized body of knowledge and pursue original research under the guidance of outstanding faculty. ### C. Research

The Ph.D. program prepares students for scholarly research in colleges and universities or for applied research in nonacademic settings. We expect our students to develop the theoretical proficiency, research competency, and professional expertise to conduct high quality empirical research. We expect our students to present their research at the premier conferences in Sociology and to publish their research in the top journals of the discipline. We expect our students to explore opportunities to support their doctoral training and dissertation project with external funding.

<u>Mentoring.</u> Each member of the in-coming cohort receives, before they arrive at UF, a mentoring team comprised of a faculty mentor and graduate student peer mentor who work in her or his field of interest. Upon arrival, they meet with their mentors to discuss plans of studies and expected coursework for the first academic year. At the department orientation, each student receives a proposed schedule of coursework, qualifying examinations, and research projects for completing the degree on time. By the second semester, each student has selected a dissertation advisor.

<u>Curriculum.</u> The curriculum provides students with required courses in research and professional development early in the graduate career. The ProSeminar in the first semester guides students through UF policies, ethics in sociological research, scholarly writing, and review of program faculty research specialties. Doctoral students are required to complete courses in research methods designed to provide basic competency in completing independent research. Students complete a course in Research Design that introduces multiple methodological techniques and experience in writing research proposals. There is an integrated three-course sequence in quantitative methods and advanced statistics, and an integrated two-course sequence in basic and advanced qualitative methods.

<u>Annual Review.</u> Faculty established program benchmarks, remediation plans, and criteria for separating students from an ill-fitting program, all of which are clearly detailed in department documents, forms, and the website. Faculty meet to evaluate students' progress and accomplishments relative to program benchmarks and the performance of their admission cohort. Each student receives written documentation about their progress through the program and their professional development. Underperforming students receive an individualized improvement plan that specifies the criterion in need of improvement, strategies suggested to achieve that improvement and target dates for accomplishing the improvement.

<u>Department Support.</u> The department maintains computing hardware and software in a centralized workspace for students to complete quantitative and qualitative research programs. The department provides funds, to each graduate student who requests it, for travel to professional conferences. We actively support graduate student applications for travel monies through various mechanisms at UF.

### F. Measurement Tools

Content knowledge and skills SLOs are measured with successful completion and oral defense of the qualifying exams, dissertation proposal, and dissertation. Students complete 4 sets of written and oral qualifying exams: methods, theory, primary area, and secondary area. A sole-authored published paper in a secondary specialty area may be substituted for the secondary area exam. The Ph.D. chair and committee determine whether the exams, proposal and dissertation meet standards for passing. Successful qualifying exams are measured by pass, conditional pass, or fail. Conditional passes require the student to write an essay that demonstrates subsequent mastery of the content area, and/or complete additional substantive coursework or methodological training.

Professional behavior SLOs are measured by the successful completion of on-line training programs at UF and successful completion several professional activities in the required first-semester ProSeminar. Students are required to print out the certificates of completion and the certificates are placed in their files. Students prepare a curriculum vita, a research proposal and a professional research oral presentation in the ProSeminar, each of which is graded with an assignment-specific rubric.

SLOs are benchmarked as key events at specific times, and summarized in footnote 1 of the annual review rubric (see Appendix A). Progress through the program is first assessed by the committee chair in the 1<sup>st</sup> line of the Committee Chair's Assessment section and then evaluated and rated by program faculty in the department rating section.
