F. Measurement Tools

Direct Assessments

Assessment metrics were agreed upon by the entire faculty.

The Knowledge SLO is measured by the student's performance on the M.S. written exam. The written exam is graded in terms of pass, conditional pass, or fail. Students have two chances to pass the exam – the first chance occurs after the first year of courses in May, and the second chance occurs in August of the same year. The distribution of exam scores varies from year to year. Instructors of four courses create the exam. A threshold for successfully completing the overall exam is determined by the Exam committee in consultation with the instructors. A student who exceeds the threshold is judged to have passed the exam. A student who is close to the threshold but with low scores on the exam component for one or more courses may be given a conditional pass and have to retake the relevant course(s). Otherwise, the student fails the exam and may take it one more time.

The Skills SLO is measured by the student's performance on the M.S. culminating experience. This is an oral exam and a written report critiquing an article from the statistical research literature. Each student works together with his/her advisor to choose an article, digest it, and report on it. Usually the student simulates data and applies the new statistical method. The grading scheme is pass or fail.

The Professional Behavior SLO is measured by the student's performance on the consulting report, which is graded according to the rubric shown in Appendix A.

Indirect Assessments

We will indirectly assess student performance in our program by relating exiting GPA to entering GPA and GRE, using regression methodology, measuring annual retention rates, and measuring employment rates.
