#### F. Measurement Tools

At the end of the final clinical experience, the student's supervisor completes the Individual Supervisor End-of-Semester Report Form (ISESR) (Appendix 1). The Individual Supervisor End-of-Semester Report Form (ISESR) is completed for each candidate by the following: individual faculty members, adjunct teaching the content of practicum and internship, field supervisors at practicum and internship sites, and supervisor of group and individual supervision. Candidates must score 4 points or higher in each required area of the areas stated in the ISESR in order to meet the standard requirement. At the end of each spring semester during the program, candidates complete an annual evaluation process that includes documenting activities such as memberships in professional associations, attainment of certification or licensure, and activities demonstrating the adherence to ethical practices and standards. Additionally, candidates must successfully write, present, and defend the thesis in the final semester of the program.
