1. Approval of draft minutes from December 4th meeting

Minutes reviewed and approved

- Motion for streamlining of Minutes, forego recording of individual names

• Also investigating best ways to streamline and incentivize use of assessment on campus website by faculty.

8. Vision for UF Common Core – Angela Lindner

Discussion of UF Core Proposal

Dr. Lindner recommends the book, "Helping College Students Find Purpose: The Campus Guide to Meaning Making" (Nash & Murray, 2010) Discussion:

- N and D designations. Why not embedded and could it be reviewed?
 O What about embedding N and D designations in the e-portfolio?
- Recommended to avoid use of "Common Core" phrasing, but rather use "UF Core" or a similar iteration.
- Portfolio Assessment
 - Question arose as to whether the assignments would be graded. The Task Force assigned to this area will provide recommendations.
- Would this would be in addition to 36 hour General Education requirements?
- Are science students steered towards sciences courses in the 2nd year?
- Research and external engagement rather than folding them under 3rd yr experience.
- Army reserves, students working (20+ hrs a week); will that work for experiential?
- Core experience 2; should be courses that look at nexus of social science and natural science. Do not make a distinction between Social and Natural Sciences but, rather, include in one category of selections.
- Common reading program incorporation?
- How is this providing a "UF Experience?"
- Some concern expressed about possible misuse of zero-credit courses.
