- 2. Gordon Rule Writing Proposal (distributed pg. 2 meeting handout) was approved by the Senate Steering Committee to be presented to the Faculty Senate at the February 21, 2008, meeting as an information item. Kim Tanzer encouraged all Committee members to be present at this Senate meeting and to discuss the proposal with their College Senators prior to the meeting. Students with scores of 3 and above receive 6000 word writing credit for certain UF courses even if these courses are not Gordon Rule certified at UF. We will research the resource issue of having these students complete their writing at UF. Suggested every student must complete at least one writing course while attending UF.
