1. Minutes from September 27th meeting were approved with the following corrections:

<u>MEM 3301</u> *Palaces and Cities*, Denied N. At the September 6th meeting, the International (N) designation was denied because the syllabus did not demonstrate how students would learn to evaluate their "own cultural norms and values in relation to those held by the citizens of other countries", and "develop a cross-cultural understanding of the rest of the world". The syllabus was revised but it still did not focus enough on the contemporary requirement for the international area.

Elif Akcali and Tanya Koropeckyj-Cox had teaching conflicts with their General Education review assignments so they would be unable to attend the classes.
