ANT 3478 Global Health Cultures,

Comments: This proposal seems to meet all requirements and is properly formatted for review.

NSC 1140 Sea Power and Maritime Affairs,

Comments: The syllabus is missing many requirements, such as office hours, UF grading link, attendance policy and disability statement. The make-up policy does not meet UF standards, and there is no writing rubric. There was a discussion concerning the general

5. Status on Statewide Core

It is expected that the Chancellors will approve it since the BOG Interim Chancellor was on the conference call.
