#### 1. Welcome and Introduction

#### 4. GE Assessment Subcommittee – David Julian

#### 5. Revision of text on General Education website:

#### • Writing Requirement

Julian and O'Sickey collaborated with the catalog editor to align language on the General Education website, regarding Writing Requirement courses, with what is in the catalog. The committee requested that changes to the language be made to clarify how group work is handled when grading for Writing Requirement credit. The committee agreed that it is not necessary to require all feedback on written assignments to be provided by the last day of classes, but rather by the end of the semester. Julian and O'Sickey will make the necessary edits by the next meeting for committee approval.
