AMH 2020 *United States History since 1877*, Denied. The syllabus needs to conform to the UF and the General Education Syllabus Policy. The explanation of how the course meets the Social Science (S) designation cannot presume that history is a social science; it must make the case that this history course meets the (S) designation.

The committee had concerns that three of the books for the required reading are fiction and the main historical text is listed as recommended instead of required. Tanya Koropeckyj-Cox and John Krigbaum will offer to help the department revise the syllabus.

CLA 3405 *Gender and Sexuality in the Ancient World,* Recycled. The syllabus needs to include a verbatim statement of the general education objectives for the Humanities designation area, and a writing rubric. The author's name on the writing handbook is misspelled; also the syllabus needs to be checked for typographical errors.

3. Syllabus Checklist

The General Education syllabus checklist should include the requirements listed in the General Education Course Syllabus Policy.

For Writing Requirement courses, the syllabus checklist should include the following requirements:

- a writing assessment rubric (<u>sample rubric</u>) or detailed explanation of the evaluation criteria for written documents
- information on, or a link to, the university's Writing Studio (<u>www.writing.ufl.edu</u>);
- a recommendation of a writing or style manual.
