#### **Chair's Report**

## Paul Davenport, Chair

- A resolution from a faculty member that concerned a university endorsement was received and will go through the usual process. Dr. Davenport forwarded to the Welfare Council.
  - After discussing with the Provost, in the future when the administration speaks publically, they will self-identify. For example, if the administration states publically that the "university" takes a position, then it will go through the senate beforehand. However if the administration takes position, then it will state publically that the "university administration" is taking a position.
  - All resolutions will go to a council for recommendation before returning to the Steering Committee.
- The Senate sponsored Academic Freedom Symposium will be in the fall due to short period of time between now and end of the academic year to organize.
- The Universities Libraries Chair has requested that the ULC should report to Research and Scholarship Council instead of Infrastructure Council. The Committee on Committees is reviewing that recommendation.
- Faculty Club (current plan)
  - The line building of the new parking garage that will be built behind McCarty will house the Faculty Club on the top floor. Plans are moving forward on this project.
