- Jane Adams gave an update on the new lobbying statutes and house rules.
 - Any UF employee who requests funding or advocates for or against legislation involving the university must register as a lobbyist and file disclosure forms when meeting with House members or staff.
 - To avoid unintentional violations, faculty and staff must contact University Relations or IFAS Government Relations before they communicate with legislators or staff.
 - Some items on the UF Legislative Request are:
 - Faculty Investment \$20M (recruit new faculty)
 - Faculty Retention \$30M (bridge salary gap between UF and peers)
 - Graduate Students \$10M (increase stipends)
 - Reduce Student Faculty Ratio \$15M (by hiring 125 faculty members)
