Minutes

Allison welcomed everyone and called the meeting to order at 3:33 PM. Minutes were approved from the April meeting.

Speaker: Beth Roland, DRC

- 1) The mission and vision of the DRC have been revamped.
 - a) The new mission and vision can be found at this link: https://drc.dso.ufl.edu/about/history-and-mission/
 - b) The DRC has also moved out of the Dean of Students office and under the Student Success and Retention Initiative.
- 2) ADA Definition of Disability:
 - a) An individual with a disability is a person who:
 - i) Has a physical or mental impairment that substantially limits one or more major life activities OR
 - ii) Has a record of such an impairment OR
 - iii) Is regarded as having such an impairment.
- 3) Main models Disability
 - a) Medical and Charity Models
 - How disability has been viewed in the past, but the DRC does not plan to utilize these models.
 - b) Social Model of Disability
 - i) Disability is a social limitation that is not a result of the state of the body, but a lack of fit between the body and the environment.
 - ii) Recognizes that society perpetuates disability.
 - iii) Recognizes disability as an identity.
 - iv) What DRC plans to promote moving forward.
 - v) This model is also embraced by AHEAD, the national organization for higher education and disability.
 - c) DRC Students to date in 2017-2018
 - i) 3055 students
 - ii) From all programs- undergrad, graduate, and professional
 - d) Categories of disability:
 - i) Mental Health Impairments
 - (1) Fastest growing category
 - ii) Attention Deficit/Hyperactivity Disorder
 - iii) Learning Disorders
 - iv) Medical/Chronic Health Conditions
 - v) Hearing, Vision, traumatic brain injury, Autism
 - vi) Physical/Mobility Impairments
 - (1) Cypress Hall is a residence hall that is equipped with additional services for students with mobility impairments.
 - (2) Cypress Hall currently has 11 lift systems and UF has committed to adding 5 more in Fall.
- 4) Initial DRC appointment
 - a) How to schedule an appointment?

- i) Feel free to ask a student if they've ever used the DRC before, or if they are aware of the DRC.
- ii) The DRC is moving to an online appointment scheduling system.
- iii) Right now, they can schedule an appointment by calling the office.

- b) At the appointment
 - i) The DRC learning specialist will ask the student to describe what's going on in their classes.
 - (1) It's common that a student may only be experiencing a barrier in one class and is seeking an accommodation specifically for that course.
 - ii) The student can leave with an accommodation plan.
 - (1) They'll get a letter that they can email to their instructors.
 - (2) It's important for the students to advocate for themselves when speaking with their instructors.
 - (3) Most common accommodations are for testing: low distraction environments and additional time for exams.
- c) Follow Up Meetings
 - i) DRC offers Student Success Appointments to help students with time management, study skills, etc. with a disability lens.
- 5) Medical Withdrawals
 - a) DRC can help with medical withdrawals but will always refer students to the Care Team.
- 6) Student Services Offered
 - a) Academic Accommodations
 - b) Academic Coaching
 - c) Disability Management Counseling
 - d) Programs/Outreach to celebrate Disability
 - e) Assistive Technology Resources
 - f) Ongoing Access and Support
- 7) Student Empowerment
 - a) Delta Alpha Pi International Honor Society
 - b) SOCIAL Gators: Group for students on the Autism spectrum
 - c) Ambassadors for Disability Awareness: Student Organization
- 8) Why Talk about Accessibility?
 - a) Some factors that contribute to students with disabilities not finishing:
 - i) Students with disabilities do not have lower GPAs, but may have some barriers:
 - (1) Learning barriers in the classroom
 - (2) Inconsistent academic accommodations
 - (3) Lack of campus wide awareness of disabilities
 - (4) Lack of accessible involvement opportunities
 - (5) Negative perceptions of faculty/instructors.
- 9) Universal Design
 - a) Also called inclusive design, design-for-all, lifespan design, or human-centered design.
 - b) If it works well for people across the spectrum of functional ability, it works better for everyone.

Chair Updates

- 1) The application for NACADA travel scholarships has been sent out!
 - a) The deadline to apply is June 4th.
 - b) Departmental support to submit the application is required.
 - c) If you have questions, reach out to Allison.
- 2) Dr. Lindner wasn't able to make it to today's UAC meeting, as previously scheduled.
 - a) She is meeting with her counterparts from the other SUS institutions today.
- 3) The Provost has seen the NACADA consultation report.
 - a) The report is still being reviewed.
 - b) The goal for the Summer is to review the report and share the results.
- 4) Civic Literacy Requirement
 - a) Will start for students entering in Summer B.
 - i) Required for both freshman and out-of-state/private transfers.
 - ii) Students with in-state AA degrees will be exempt.

- b) The test will hopefully be available around July 1st.
 - i) They can meet the requirement by getting a 60% or better on the test.
 - ii) It will be a 100 question test through Canvas, developed by the state.
 - iii) It will not be proctored.
- c) AP, CLEP, or Florida public school credit for either AMH 2020 or POS 2041 will satisfy the requirement.
 - i) IB credit for AMH 2020 will NOT satisfy the requirement.
- 5) COMPASS
 - a) Meetings between COMPASS team members and advisors are ongoing.
