Heather called the meeting to order at 12:07 PM. The April minutes were approved.

## Proposed Edit to Constitution to Include Addition of a Senate Committee

The Committee prepared a draft of language to include at Article V, Section IV of the Constitution. Richard moved to approve the draft; motion was seconded by Christine and the motion passed. After approving the language, the Committee made one small edit. The revised draft was accepted upon a motion by Sophia, which was seconded by Richard. The proposed language draft is attached.

Meeting adjourned at 1:25 PM
(E) University Information Technology Committee. The University Information Technology Committee shall be composed of seventeen voting members, one member from the University Libraries and one from each of the sixteen colleges. Members will serve staggered three-year terms, and may only serve one consecutive term. Faculty members of all ranks are eligible for membership. The Chair is elected by the Committee and will serve a one-year term. The University Chief Information Officer, and two appointees of same, shall serve as liaisons to the Committee. The Committee shall provide advice and assistance to the Chief Information Officer on matters affecting information and communications technology. The Committee shall assist University leaders in developing and updating a strategic plan for information and communications technology. The Committee shall advise the Faculty Senate on all information and communications technology policy matters affecting the University. The Chief Information Officer or her or his designated liaison shall present matters of policy to the Committee in a timely manner, provide the Committee with pertinent details about information and communications technology network policy changes, and report to the Committee on actions taken in response to the Committee's recommendations.

## 6. Changes to IT Committee Language

From Frank Bova, chair IT committee:

My only concern is the term limit. As with some committees the learning curve tends to be steep and having a productive committee member with accumulated history is often beneficial. Can we ask if the wording " unless an additional term is requested by the college faculty council". Would allow some to continue for an additional term and if the member is not providing good college service they can not request the extension.

Regarding our question about if they realized the implications of how committee members were chosen:

- yes, they do. They are trying to keep faculty involved, not have membership slip into support groups that are around the campus (IT professionals, ie not the users of IT). The idea was that faculty councils (bypass deans) would help find faculty who would serve. This is similar to how they select senators - they go back to the college, the college puts for names.

Regarding our question about having student representation:

- They have since had a discussion with the president of student council to have students on the IT committee - it would be beneficial to have a couple of different students on it (professional students vs main campus vs law students etc ... ). They will encourage the student government to put together 2-3 students from different parts of campus for full representation of the student body. We need to put language into the constitution about these 2-3 students from different areas of the student body. I forgot to ask for clarification about if they are voting members, so for this draft we'll assume they are not (as they are not in the other committees) and then see what they say after October's revision.
