Prerequisites Completion of Aural Skills 1 and Aural Skills 2

Co-requisites none

Rationale and Placement in Curriculum This is the third course in a four-course sequence which is required for all music majors. We are separating the written work from the aural work in order to provide a better fit for our students who enter UF with a wide variety of musical backgrounds and musical training.

Course Objectives This course develops student skills in the disciplines of sight singing and melodic, rhythmic, and harmonic dictation.

Upon completing this course, a student will be able to sing and dictate major and minor scales, ascending and descending diatonic and chromatic intervals, triads and seventh chords in root position and inversion, diatonic melodies comprised of stepwise motion and leaps, chromatic melodies with tonicization of closely related chords, and complex rhythms including tuplets and syncopation. As sight singing and ear training are skills that can only be developed through practice, students are expected to work on these skills outside of class meeting time for at least three hours per week.
