If you prove unable to answer these questions, I will assume that you have not prepared the homework and will dock you 1% of the homework preparation grade. You will lose 1% on each occasion that you prove unable to answer these basic questions.” [Updated, 11/8/16]
  - “Note that Tuesday’s double class counts for 2 classes and an unexcused absence in this class will result in the loss of 2% [of what?]. Students should also note that there is no limit to these deductions and, as such, a consistently poor attendance record will result in a significantly lower grade or even a fail.”
    1. This needs to be brought in line with UF policy. One class absence cannot count as two.
    2. If students are continuously absent shouldn’t they be dropped?
