Proposed Changes We are revising the minor by replacing the current three tiers of electives (i.e., Category 1, 2, and 3) with two tiers of electives: Category A (Theories of Social Inequality, Difference, and Power) and Category B (Health Systems and Social Justice Mission).

Pedagogical Rationale/Justification At the time this minor was created, there were few courses that could satisfy the minor's mission of critically examining the health disparities that exist at multiple levels of society (global, national, institutional, local, and personal) and among people of diverse geographic locations, linguistic groups, socioeconomic status, and sociocultural groups. This led to the creation of 3 categories: Category 1 - Health or Social Science of Minority/Cultural Groups in US, Category 2 - Social Inequality and Related Theory, and Category 3 - International or Global Studies. When the minor was created, few courses could meet both the requirements of what are presently Category 1 and 3 and continue to focus on health. We were required to count courses that were about the social science of minority groups generally (i.e., without a health focus) or that were about international culture, again often lacking emphasis on medicine, health, or health disparities. However, through growth in our unit and others in CLAS, there are now a sufficient number of courses that focus on both knowledge about diversity, minority groups, and power structures and health or medical outcomes. As there is a sufficient number of courses being offered that are more inherently related to the mission of the HDS minor, we find it logical to combine what are presently Category 1 - Health or Social Science of Minority/Cultural Groups in US, and Category 3 - International or Global Studies into Category B - Health Systems and Social Justice Mission. Having Category B instead of Categories 1 and 3 will allow students to take courses that are more specifically related to health systems and social justice missions on local, national, and transnational levels. As proposed Category B is essentially the combination of what are currently Categories 1 and 3, we also find it logical to require 6 credits from this proposed Category to give students the opportunity to learn in depth about health disparities faced by often-marginalized groups of people at local, national, and transnational levels. **Impact on Other Programs** The proposed modifications for this minor all concern elective courses. To satisfy the requirements for the HDS minor, students will be required to take 9 credits of electives (as is the current requirement). As listed in the proposed changes in the course catalog, there are many courses available for students to take to complete the HDS elective minor requirement, but no specific course is required. Thus, there should be no impact on other programs or departments.

At the request of the UCC, we obtained consults from PHHP and HHP about the proposed changes. PHHP requested that we retain one of their courses, and we have done so. Both units have offered their approval of our plan (see attached emails).

## **Health Disparities in Society**

Health disparities describe the disproportionate burden of disease, lack of access to health care, and poorer health outcomes found among members of socially disenfranchised populations. Health disparities exist at multiple levels of society (global, national, institutional, local, and personal) and among people of diverse geographic locations, linguistic groups, socioeconomic status, and sociocultural groups. Housed in the Center for Gender, Sexualities, and Women's Studies Research (CGSWSR), the Health Disparities in Society (HDS) minor provides an interdisciplinary, intersectional framework to examine how multiple social identities (e.g., race, gender, sexual orientation, and socioeconomic status) intersect to reveal interlocking inequalities, and Women's Studies Research (CGSWSR), the health disparities minor examines the ways in which ethnicity, national identity, race, class, ability, gender, sexual orientation, geography, education, and other factors create differential access to and quality of healthcare, producing disparate health outcomes.

Related Women's Studies Programs

#### Overview

Coursework will raise awareness among students about health disparities and establish a foundation for skill development and critical thinking about the assumptions that shape life science, medical research, and clinical practice. The minor will provide a framework that teaches students to integrate concepts of culture and health disparities into their personal and professional development.

#### **Eligibility for the Minor**

Due to the potential for significant overlap in coursework, Women's Studies majors must appeal to the CGSWSR for approval for the minor. Appeal forms are available in the department office in <u>Ustler Hall</u>.

#### **Requirements for the Minor**

No more than three credits of independent study may count toward the minor.

Students must complete a minimum of six credits of coursework exclusive to the minor that cannot count toward the major(s) or other minors.

Sometimes, and with the approval of the undergraduate coordinator for Women's Studies, students may petition to have other, relevant classes approved as substitutes within each category of electives within the minor. Such courses could include department *special topics* offering with numbers like 3930, 4930.

Each semester, courses offered for this minor are listed on the Women's Studies courses website.

Dear Dr. Janelle—I am writing today in my capacity as Undergraduate Coordinator in Women's Studies, where we administer the minor Health Disparities in Society. One of your department's courses, HSC 4624 Trends in International Health, currently counts in the minor as a category three elective (you can see more info here).

Over the past 18 months, a committee has worked on refining the HDS minor based on what we have learned in the past five years of offering the minor, advances in the field toward more explicit structural analysis and equity/justice framing, and changes in course offerings at UF. Among multiple refinements to the minor, one change we are proposing is to our elective structure. We have developed a new description of the elective category, "Health Systems and Social Justice Mission," which now includes course options that focus explicitly and substantially on how health systems are connected with equity and justice issues; that is, each course reflects a focus on both health systems AND equity and justice (rather than either/or).

The committee reviewed existing course descriptions and syllabi that were available online. Based on that information, and in line with the proposed modification, we have proposed dropping HSC 4624 from the list of approved electives from the minor.

The minor modification proposal went before the UCC recently and that committee requested that we seek a consultation from HHP about dropping this course. **Could you please let me know if you have any concerns with this proposed drop**? I'm also happy to talk on the phone if you would like me to clarify anything about this request. Thanks. –Alyssa
