2. Update from the Faculty Senate. Dr. Lindner: nothing to report.

3. [Proposal to reduce credits for Nursing BSN curriculum, effective Fall 2018. Anna McDaniel](#) Dean Anna McDaniel presented on their BSN Curriculum Transformation Project. Nursing was cited as being unique in the health professions as an undergraduate degree leads to become a professional. This means there is only two years in upper division to compress all of the knowledge needed.

The current curriculum has been in place since 2010, and over time has resulted in a gap between students' potential and the outcome metrics desired. A review showed that students' weren't achieving their goals and so it was decided to look towards national recommendations to improve progress and shift the thinking towards knowledge based clinical practice. The proposed curriculum builds on success in the previous semester and involved doing comparisons to national programs. Clinical success is considered a threshold that must be achieved to be successful in the program.

 - Grading for courses, separates clinical practice as S/U and stipulates that a student earning a U in the clinical component fails the course regardless of letter grade.

- This is not consistent with current University of Florida grading philosophy. Please explain why this grading approach is necessary for the courses/program.
- Please provide a detailed description and explanation of clinical grading S/U.
 - a. How many times a semester are the students evaluated?
 - b. What is the minimum required effort for ‘S’?
 - c. Are there options for remediation?
- Must be consistent in required HESI test score in courses. ~~Course request forms list 800, this needs to be included in catalog copy (which currently states 700).~~
- Please change “HESI” to “External Nursing Skills Test”, or similar generic title (as the test provider may change in the future).
- What is the regularity of the course offerings? I.e., if a student fails a course what are the options to retake the course?

 - **Please clearly state which courses are no longer taught in the request form.**
 - **Will these courses be deleted? [HPS 3003 “Perspectives in Science and Mathematics” and ISC 3523C “Research Methods” are no longer consistently being offered by CLAS. We originally were able to rely on each of these courses being offered at least one semester per year (either fall or spring). With personnel and funding changes in CLAS, these courses may still be offered on some rotation but they are no longer consistently offered yearly. We propose to delete HPS 3003 and leave ISC3523C or any other research methods course as an option for the “additional 3 credits” required towards the major (see year 3 in the chart in the catalog copy). Email, 3/19/18]**
 - **Please clarify semester plan changes. The deleted section shows courses by year. The new chart just lists courses. Does this mean that students may take those courses in any order? [We have revised the submission to include a chart outlining a suggested sequence of courses over the course of four years. This is one possible sequence for students to follow, but we are aware that many of our students do not begin the minor until their 2nd or 3rd year of undergrad, so we recommend strongly that all students see our advisor to develop a specific degree plan to accommodate the course sequence within the semesters they have remaining in their time before graduation.]**

- If courses like ISC3523C are no longer offered, thus prompting at least some of the requested changes to the minor, then those course numbers should no longer be part of the list of courses from which students will choose (see list of courses A-C under Proposed Changes section of UCC form). If the department is permitting substitutions for a course because it's no longer offered, that should be reflected in the catalog if the department knows the course is not actually being offered. It looks like the catalog copy does in fact account for this, but the UCC form itself is unclear. Please clarify on form. Will a request be submitted to delete these courses from the catalog? **[We have no desire to delete courses from the catalog, our intent is to accommodate for the fact that these courses are no longer reliably available each year by giving students more flexibility in their options to complete the minor in a timely fashion.]**
