SYLLABUS

General

Course Description:

GeoDesign is a relatively new term, but it describes an activity which is not new. GeoDesign involves various disciplines (such as urban planning, landscape architecture, physical sciences, information technology) collaborating to design solutions to current problems with a spatial focus (such as climate change, population growth, resource limitations, etc).

The course will expose students to GeoDesign topics through presentations from a variety of professionals and academics engaged in GeoDesign work. Some presentations will be online and others will be in house. It is intended that the presentations will invoke discussion amongst the students, in an effort to understand the scope, applications, and implications of GeoDesign principles.

Students will be assigned a final project, involving a short presentation about a GeoDesign project of interest to them. The final two weeks of class will cover class presentations.

Course Objectives:

At the end of the course students should be able to:

- Describe the various disciplines that collaborate in GeoDesign work
- Describe at least five different types of projects that involve GeoDesign
- Identify projects and research that utilize GeoDesign
- Classify the types of current problems that can be addressed with GeoDesign

Weekly Written Reflections – 50%

• Each week students will be asked to submit a written reflection, no less than 1 page in length, on the classroom presentation/discussion. Each reflection will be uploaded as a pdf through the course management system by the due date.

Final Project – 40%

 Students will be assigned a Geodesign project to research. A presentation (40% of the 40%) will be required as will a paper (60% of the 40%). The final presentation will be assembled using MS Powerpoint, and will be uploaded through the course management system in advance of class. The final paper will be uploaded as a pdf through the course management system by the due date.

Attendance - 10%
