The nature of the AT industry is changing so students could major in anything and still be eligible for an entry level masters program. - Description: The Professional Certificate in Driving Rehabilitation Therapy (DRT) is a 21 credit program that includes on line and residential course activities to train regulated health care professionals to provide driving rehabilitation services for clinically at-risk populations through the lifespan.

 - ~~Please provide more detail regarding the nature of this certificate. 21 credits seems to be a heavy certificate credit load.~~ **[There is precedent for**

this type of certificate credit load at UF and the 21-credits for the DRT Program is a reasonable expectation for this type of content. In addition, the targeted student audiences are professional licensed health providers (OT, PT, SLP, Clinical Psychologists, Nurses, etc.) who will participate primarily via distance and therefore set their own schedules. In addition, the DRT program advisory committee is set up to consider the need for program extensions on a case-by-case basis. Email Response, 9/15/17]

- ~~Is this certificate designed for students currently in other programs?~~ [Any student who meets the admission criteria can enroll although the primary expected audience will be health care professionals. The admission criteria are outlined below: :
 - Possess at least a Bachelor's degree or equivalent from an accredited university in any discipline
 - Be a licensed/regulated health care professional (e.g., occupational therapist, physical therapist , speech and language pathologist, clinical psychologist, nurse, kinesiologist)
 - Have a minimum B average.
 - Have at least a 75% average across courses taken in the last two full-time years of the undergraduate degree.
 - Have a minimum of two years of clinical experience
 - Have a valid driver's license
- ~~Is this certificate required or in preparation for the ADED certification examination?~~ [Although not required for certification, one outcome of the certificate is that students will be adequately prepared to complete the ADED examination. The DRT certificate provides students with the opportunity to access appropriate content all in one place. Email response 9/5/17]
- ~~Is this meant to take the place of the previous master's program?~~ [No this is unrelated to the master's program we offer, which is being replaced with the doctor of OT. The DRT program is a post-professional certificate building on the skills of bachelor or master trained professionals with an interest in Driving Rehabilitation Therapy. [Professionalism is one of the six competencies required for our accreditation with the LCME (Liaison
