  - Quizzes are weighted 1-3% totaling to 19.5%. Please designate the weighting for each quiz, possibly in the table on page 10 of the syllabus.
  - Make-up of quizzes, exams, problem sets, group project work for excused reasons:
    - 1. Pages 4 and 5 of the syllabus include strong wording that implies a student missing the deadline for submitting assessments and assignments because of an excused reason will not be able to make up that specific work. This violates UF policy if true. Even the class policy to "allow" a student to take a cumulative final if s/he misses an exam does not align with the spirit of UF policy, given that this option penalizes the student with an excused absence compared to other students.
    - 2. While we understand the intention of the instructor in strongly reminding students to be mindful of deadlines, the instructor must include accommodation and a process for students who have excused reasons for not submitting this work on time.
    - 3. An additional concern is whether students who do not complete a module on time will not have access to the missed module's content after the closing date of that module. If this is the case, this would be additional penalty for students beyond grades of "0" in the missed work. Can you please clarify?

[The course can be taken as one of those to fulfill the 30 hours of course requirements for the major and 15 hours for the minor. It is not a required course though. Email 9/14/16]
    - The request states that this course satisfies requirements for the African American Studies major and minor and for the History major/minor. If indeed true, a curriculum change request for UCC's review should be submitted. [Not required for either. Email 9/14/16]

Will students be required to have a laptop in class? [Students are required to have a serviceable laptop and a headset in order to avoid audio feedback issues that may otherwise arise. It is not necessary for students to bring their laptops to class. Email and Added addendum to request. 9/14/16]
  - Will there be a class policy regarding the absence of a group member and how that will impact the grade of the group/individuals? [If the committee thinks such a policy is needed, I will add one, but I'm not sure it is needed. Students are graded for the work they do, and the work is divided so given students can complete their parts even of one (or more) of the group members does not complete their work. Email 9/14/16]

- Please obtain a consult from College of Education
  - 1. [EMAIL RESPONSE 9/12/16 We have requested this form from the faculty in Bilingual ESOL education, since that seems to be the area that is most relevant to the current class. However, they only offer graduate programs, so there is no real overlap. The only undergraduate programs offered by COE are in early and elementary education (5 year BA+MA) and in those study plans there are NO courses that relate to language teaching or learning, or world languages at all. This is not a focus of the COE, nor has it been for several years.]
  - 2. [Additionally, the course we propose here is NOT a methods class that is related to any sort of teacher education certification program. It is designed to be an exploratory class for students to learn more about language education in the US in Spanish. While particularly useful for those considering careers in education, most students over the past two years have not had any connection (coursework, minor, major) to the College of Education.]

- \*- Will this be a required course for any major, minor, certificate? If so, subsequent approval request will be required.
  - "Our department is expanding our offerings in Languages for Specific Purposes (LSP), in order to attract new students and to provide more coursework options in our Certificate in Spanish for the Professions. This course has been taught as a rotating topics course and was quite successful." [The courses is an elective that can be used to fulfill one of the four required courses for our certificate program, or can be used to count towards the major or minor. It is not required for any degree program. Email 9/12/16]

#### - Practicum/Observations:

- 1. "Each member of SPN 3XXX will have the opportunity to engage with educators and learners in Spanish in local PK 12 settings during a placement of a minimum of 12 hours."
- 2. Will students need to have background checks/be fingerprinted by local school system? [Students do not do a student teacher-type placement that requires a Level 2 background check. Instead they are classified as volunteers. They complete the Alachua County Public Schools Application to Volunteer form (attached for reference). After students submit their forms, ACPS staff check the FDLE Sexual Predator site (as made clear on the form). Email 9/12/16]
  - a. Please check for any mandatory fees students may have to pay for class observations. If there are any such fees please include within the syllabus and approval request. [There are no fees associated with completing the ACPS Application to Volunteer.email 9/12/16]
- 3. Are the 12 hours required outside of the lecture period, or will students miss lectures to participate in the observations? [There are days when classes are not held; these are indicated on the syllabus ("No hay clase Tiempo para prácticas" / Translation: "No class Time for practicum"). In Fall 2016, four classes (the equivalent to roughly 6 hours of class) are canceled so that students may use that time plus the time they would have used to prepare for those classes towards their experiential learning. - What determines whether a student works alone or in a group in the final project? If the latter, how are students graded? [The complete description and rubric document for the final project is attached. Students decide what the focus of their projects will be and whether they will be completed individually or in small groups. In Fall 2015, two projects of eleven total were group projects (i.e., the vast majority of students do individual final projects). They submit their preliminary ideas to the professor via the Proposal for the Final Project (pp. 4-5).

Once the project is approved, each student maintains an activities journal noting what work they've done on the project and when (p. 6). This journal is reviewed by the professor every two weeks to ensure that students are working on the project steadily (and also to make sure that students working in groups are contributing equally to the success of the project). Other group members must also review the activities journal and attest to its accuracy.

Each project will be evaluated using the project rubric on pp. 7-10. As the note on p. 10 indicates, the professor reserves the right to differentiate grades of group members

as needed based on a final evaluation of the activities journal. Email with document 9/12/16]

That is, the peer "score" is really only a quantitative exercise for the reviewers but we will provide them with feedback if, after several weeks, an individual is consistently grading above (usual) or below (rare) the TA score.
