• Legal History, effective Summer B 2019. Joseph Spillane

Dr. Spillane explained that legal history is a recognized sub-field and would be very attractive to students interested in the legal profession. He said that the courses offered for this certificate should be different from the courses offered to students pursuing a bachelor's in history to prevent overlap, or "double-dipping," but this needs to be verified to align with certificate policy.

It was suggested a set of courses with a core student learning outcome should be established so the certificate would be earned in a uniform way. It was confirmed that most of the courses in the certificate would require three or six history credits as prerequisites.

Dr. Lindner mentioned that follow-up will be needed if the college is pursuing the non-degree certificate route.
