RationaleThe Accreditation Council for Occupational Therapy Education's (ACOTE) interpretive guidelines for fieldwork standard C.1.7 states "If Standard C.1.7 is met through a Level 1 Fieldwork experience, the experience must be comparable in duration and assessment methods to other Level 1 Fieldwork experiences offered by the program." In order to be compliant with this standard, the psychosocial fieldwork must have the same clock hour requirement and credit hour requirement as the two other Level 1 Fieldwork experiences (adults and pediatrics) which require 40 hours in the field and are 2 credit hours each. This proposed revision will bring the OTD in compliance with ACOTE.

PURPOSE AND OUTCOME

Course Overview: Level I fieldwork also known as Practicum is designed to afford students the opportunity to assist with hands-on assessment, treatment planning, and client intervention in the area of mental health. The student will learn to be part of the therapy team and professionally interact with clients and healthcare providers. This fieldwork provides the opportunity for students to translate their professional behavior, observation skills, performance skills, and clinical application of their knowledge into a clinical setting. These experiences may take place at in- or outpatient clinics or community based programs.

Relation to Program Outcomes: This course sequence is designed to meet the American Occupational Therapy Association guidelines for Level 1 Fieldwork Experience (C.1.0). Fieldwork education is a crucial part of professional preparation and is best integrated as a component of the curriculum design. The experience provides the student with the opportunity to carry out professional responsibilities under supervision and for professional role modeling. The goal of Level I fieldwork is to introduce students to the fieldwork experience, to apply knowledge to practice, and to develop understanding of the needs of clients.

Student Learning Objectives: ACOTE Standards

Upon completion of the assigned fieldwork experience the students will:

1. Demonstrate therapeutic use of self, including one's personality, insights, perceptions, and judgments, as part of the therapeutic process in individual interaction. (B.5.7)
2. Discuss and evaluate personal and professional abilities and competencies as they relate to job responsibilities. (B.9.6)
3. Effectively interact through written, oral and nonverbal communication with the client, family, significant others, colleagues and other health providers in your assigned setting in a professionally acceptable manner. (B.5.20)
4. Documentation of occupational therapy services to ensure accountability of service provision and to meet standard for reimbursement of services. Documentation must effectively communicate the need and rationale for occupational therapy services. (B.4.10)
5. Develop the ability to use appropriate screening and assessment tools and procedures to evaluate the client's occupational performance. (B.4.1, B.4.2, B.4.3, B.4.4)
6. Use evaluation findings based on appropriate theoretical approaches, models of practice, and frames of reference to develop occupation-based intervention plans and strategies. (B.5.1)

DESCRIPTION OF COURSE CONTENT

Course Policy And Procedures: Level 1 Fieldwork

You will be assigned to facilities within Gainesville or within driving distance of Gainesville. You will be spending approximately 4 hours at the facility every Thursday for 10 weeks. The Fieldwork Coordinator will make the final placement decisions.

1. All students must have immunization, HIPAA and CPR requirements met prior to the start date of practicum. Many sites are now requiring drug screens, fingerprints and background checks. All students must complete AIDS/HIV Training before course begins.
2. Attendance: To meet the requirements of this practicum, students must complete all site meetings scheduled. If due to illness or a similar emergency situation you must miss time, and you have not completed the full time hours, you must make the time up missed.
3. The student will be notified of placements by a posting on the course website. The name and contact information for site will be noted on this posting.
