1. **Approval of minutes of the December 18, 2007 meeting:** The minutes were approved.
2. **There were no updates from the recent Faculty Senate meeting.**
3. **Proposed curriculum change to the Women's Studies major, increasing the number of upper division hours required for completion of the major from 24 to 27, effective with the 2008-09 academic year:** Dr. Dickison explained that there are plenty of courses with space available to meet this new requirement. The proposal was approved
4. **Proposed changes to Athletic Training Curriculum, effective with the 2008-09 academic year:** Dr. McCormack Brown explained that the intent of this proposal is to require student to take BSC 2010 and 2010L. The affected departments have approved the requirement. The proposal was approved.
5. **Proposed changes to College of Health and Human Performance academic policies, effective with the 2008-09 academic year:** Dr. McCormack Brown presented a document meant to formalize many unspoken rules in the college. The proposal was approved.
6. **Proposed change in Public Health and Health Professions Bachelor of Science program writing requirement, effective with the 2008-09 academic year:** Dr. Hanson explained this will formalize what has been policy in the college for many years. The proposal was approved.
7. **Proposed changes to requirements for Anthropology major effective with the 2008-09 academic year:** Dr. Dickison presented the proposed change, requiring an additional anthropology course as part of the critical tracking criteria. The proposal was approved.
