3. Update from Faculty Senate.

The departmental merger in the College of Dentistry approved previously by the UCC has been returned to the college by the Faculty Senate for further feedback from the Dentistry faculty.

5. Proposed change to Religion major, effective Summer B 2010.

The requested revision to this major is being returned to the college for additional clarification related to the distribution of the required courses in the new proposal.

6. Proposed Changes to the Requirements for the BSBA General Business Major (Online), effective Summer B 2010.

This request is not really to update the major requirements, as that has already been done, but is to update the Student Learning Outcomes (SLO) related to the changes already made to this major. The request is being returned to the college for clarification.

7. Proposed Media Studies concentration, effective Fall 2010.

David Ostroff explained that this would be a new track with the Telecommunications major. After much discussion, the request is being returned to the college for consultation with Liberal Arts and Sciences on similar programs, for a clearer justification for the program and for catalog copy, including semester plans, to make it easier to understand the changes that would exist for this concentration.

8. Proposed BA track (Environmental Geosciences) in Geography and Geology, effective Summer B 2010.

Joann Mossa reviewed this proposal which was previously reviewed by the UCC and returned for consultation with other programs on campus. After discussion with the School of Natural Resources and Environment, Department of Soil and Water Science, and Department of Environmental Engineering Sciences, the proposal has been modified to include a set of recommended electives from other departments. The proposal was approved, pending the modification of the catalog statement related to the "interdisciplinary" nature of the program.

9. Proposed changes to Journalism curriculum, effective Summer B 2011.

Ted Spiker explained the proposed changes to the curriculum, which will add more structure to this program. It was determined that an error in the proposal and accompanying UCC forms indicated that course MMC 2100 would be eliminated and replaced by MMC 3109. The required course for this major will change, but MMC 2100 will continue to be offered and required for students with other majors around campus. The proposal was approved with this clarification.
