1. [Approval of minutes of December 12, 2017 meeting.](#) Approved.
2. Update from the Faculty Senate. No update was given as no meeting had yet been held in 2018.
3. [Proposal to modify Health Education major, effective Summer B 2018.](#) Dr. Janelle presented this request for minimum grades of C for core courses; Dr. Lindner asked for data to be collected on how many students would be positively affected by the change. Conditionally approved.
4. [Proposal to modify Advertising major, effective Summer B 2018.](#) Drs. Weigold and Kelleher presented this request to add a new specialization. The new specialization would retain many of the core courses while adding a new branding course, but allow students to tailor their curriculum via use of electives. Currently four courses need to be acted upon and are currently at the college level. Conditionally approved pending course approvals.
5. [Proposal to modify Health Science major, effective Fall 2018.](#) Dr. Hanson presented this request to create a specialization for select students where curriculum would be accelerated; 23 credit hours would overlap and this was cited as a potential concern in regards to accreditation. It was also cited that our accreditor looks very hard at combined degrees that are less than 150 hours.  
  
Conditionally approved, but want to make sure there is a strong academic justification as this would be a new high for overlapping credits.
6. [Proposal to modify Finance major, effective Summer 2018.](#) Dr. Studer-Byrnes presented this request to improve the strength of the upper division courses in the major which would also strengthen the pursuit of professional certificates. New documentation was uploaded in advance of the meeting. Approved.

The committee voted that this course should be a critical tracking course for all five majors. Transfer students would be required to take this course in Semester 5. Concerns were cited if the change resulted in 2 elective courses in the semester plan, as there are few such courses, and could result in a de facto increase in the number of credits for the degree.     - [What are impacts on students?](#)
  - **DCP 1010 is a gateway course for the major. It exposes students to the breadth of professional opportunities associated with the major and by taking this course they will be better able to make an educated choice about whether the major is a good fit for them. We want to ensure the course is taken as soon as possible.**
  - **We propose to drop GEO 4167C as a required course, but will encourage students with interest in spatial statistics to take this and subsequent courses offered to pursue that interest. We think the introductory spatial statistics course is sufficient for the majority of our students and would like to provide more elective opportunities for students in this specialization than they are currently allowed.**
  - **All undergraduate majors within the DCP are making room for the 1 credit DCP 1xxx course, Creating Our Built Environment. This will create greater understanding among all students of all disciplines in the College. This is particularly critical for SBE students, because they are likely to work across all built environment disciplines.**



- The URP Automation for Geospatial Analysis and Modeling course has evolved as quite critical for Geodesign, but was not anticipated when the specialization was created. In the short term it will focus on programming using Python, but has been entitled with a more generalized name anticipating that the optimum programming language may change in the future. Programming will allow GIS users to add iteration to their computer functions that can both speed processing and save time.
    - This will need to be added to Rationale in approval request form. 1/10/110
  - Has IDS faculty been made aware of the proposed change (eliminating IDS 2154)? Why is the course being eliminated? [No, to date IDS faculty have not been notified of the proposed elimination of IDS 2154 as one of two options in the curriculum. We will do so and submit email evidence of the notification. The course will be eliminated by removing it as an option in the wording in the undergraduate catalog. Our advisors will also advise students to take BCN 1582 rather than IDS 2154. BCN 1582 is already the course taken by the vast majority of our majors and minors. The BCN 1582 course has a greater emphasis on issues pertaining to the built environment than does the IDS 2154, and thus we feel it more appropriate, given the difference in our major from the CLAS Sustainability Studies major for which IDS 2154 was created.]
  - Why is 1 credit being added the General Education math course? [Apparently the course credits previously listed in the UG catalog for our major were off by 1 credit. This adjustment is therefore a correction rather than a change, but it does result in our having to make an adjustment to lower division elective credits to keep our lower division hours at 60. This option will also be removed from critical tracking. 2) We ask that IUP 1000 What is the Good Life? be moved to the second semester to better balance the course loads. 3) We ask that the potential credit hours for MAC 1147 Precalculus: Algebra and Trigonometry (State Core GE-M) or MAC 1140 Algebra and MAC 1114 Trigonometry (GE-M) be corrected from the current 3-4 to 4-5. 4) We ask that IDS 4930 People and Data be replaced with a GE Social Science course of the student's choosing. IDS 4930 has not been offered for a year. 5) We ask that the 1

credit course, DCP 1xxx Creating Our Built Environment be added in the 2nd semester and that the elective credit in the 2nd semester be reduced from 4 to 2.. This course is being separately submitted for approval by Associate Dean Abdol Chini.

  - [Submitter Response: I understand that the format of the submission does not allow for the connections to be made clear enough. The course was co-developed and co-taught by myself and Valeria Kleiman of the Chemistry Department and is being submitted as a cross-listed/joined course with BOTH prefixes. (There is no good way to do this in the system, so it is being listed as SPT since I'm the submitted, but we specifically requested both prefixes, and both of our departments have approved.) The course was, in spite of our disciplinary differences, an equitable blend of our fields. Every classroom meeting (2 out of 4 weeks) contained lectures in both culture/language AND chemistry, so those weeks were 50% chemistry, 50% Spanish-related. The third out of every 4 weeks took place in a chemistry lab doing hands on chemistry experiments, maintaining a lab notebook, etc., and so was exclusively chemistry related. And the fourth of every 4 weeks took place in the

kitchen (IFAS), where we focus on hands-on cooking, with reinforcement of some of the chemistry concepts, and most of the language and cultural elements. If student comments from Spring 2016 were anything to go on, the students in fact would have preferred less chemistry and more of the language aspect. We have no plans of making that change, but I point it out as a way of trying to convey that the content between disciplines was balanced. If the committee would like more information, I'm happy to table the course until I can be present at the February meeting. Email 1/9/18]
