**Rationale** BME3508 will become a required course within the BME curriculum beginning in the 2018-19 catalog year and students must take it as a corequisite with BME4503. We are also requiring students to take the BME4503 and corresponding lab (BME 4503L) at the same time as they are meant to be completed simultaneously. Knowledge of circuits will be required; EEL 3003 (3 credits) will be the new circuits requirement for the 2018-19 catalog year. We will still accept EEL 3111C if students opt to take this course (4 credits).
