Major NameEconomics Major CodeECO Degree Program Name Bachelor of Arts Effective Term Earliest Available Effective Year Earliest Available Proposed Changes The Department of Economics proposes three substantive changes to the economics major in the College of Liberal Arts and Sciences. Each is described below.

1) The department proposes accepting all 3,000-/4,000-level courses with an ECO, ECP, or ECS prefix as satisfying the "Upper-Level Coursework" requirement for the economics major, with the exceptions of ECO 3101, ECO 3203, and ECO 4941 (discussed below in item 3). This requirement implies that students must take four courses of economics or economics-related (defined below) coursework at the 3,000-/4,000-level as part of the economics major. Currently, only courses that are listed under "Required Upper-Level Coursework" satisfy this requirement. Until recently, this list included all 3,000-/4,000-level courses with an ECO, ECP, or ECS prefix, except ECS 4110, ECS 4111, and ECO 4956. The department, however, has recently added a number of new courses that should satisfy this requirement. These new courses include ECO 4401 (Mathematical Economics), ECO 4421 (Econometrics), and ECO 4708 (Economics of Competitive Strategy). The proposed new language incorporates these new courses into the major and affords the department the ability to continue increasing the curricular options for its majors.

2) The proposed new language also treats ECS 4110, ECS 4111, and ECO 4956 as equal to all other 3,000-/4,000 level economics courses. Currently, only one "economics-related" course from the following list can be counted toward the "Required Upper-Level Coursework" requirement: AEB 3450, AEB 4274, AEB 4931, ECO 4956, ECS 4110, ECS 4111, FIN 3403, and GEO 3502. The Department of Economics believes that ECS 4110, ECS 4111, and ECO 4956 should not be subject to this restriction. ECS 4110 and ECS 4111 are upper-level economics courses. ECO 4956 is used to allow approved courses taken while studying abroad to count toward the "Required Upper-Level Coursework" in the economics major. ECO 4956 equivalency is subject to review by the department in accordance with the UF International Center's academic advising process for study abroad.

3) We propose removing ECO 4941 (Economics Internship) from the list of courses that satisfy the "Required Upper-Level Coursework" requirement.

Pedagogical Rationale/JustificationThe proposed revisions allow new 3,000-/4,000-level economics courses (e.g., ECO 4401: Mathematical Economics, ECO 4421: Econometrics, and ECO 4708: Economics of Competitive Strategy) to satisfy the "Required Upper-Level Coursework" requirement in the economics major. These new

courses add breadth to the department's undergraduate offerings, and including them within the major will increase student choice. Additionally, including these courses would enhance the academic and professional development offered within the economics major.

The Department of Economics believes that removing the outside-of-department restriction from ECS 4110 and ECS 4111 will allow students interested in sustainability and development to craft a more tailors major experience. For example, students would be able to count AEB 3450 and ECS 4111 within their economics major.

Lastly, the motivation for removing ECO 4941 from the economics major is actually to facilitate the ability of student to receive academic credit for economics-related internships. Historically, if a student wished to enroll in ECO 4941, the Department of Economics required that the student demonstrate that the internship included similar exposure to and practice with economic modelling as a 3,000-/4,000-level economics course. This approach was taken, because the ECO 4941 credit would satisfy one-fourth of the "Required Upper-Level Coursework" requirement, and the department wanted to ensure that students majoring in economics were able to sufficiently develop the knowledge and skills offered by the major. In practice, meeting the threshold of "similar exposure to and practice with economic modelling as a 3,000-/4,000-level economics course" is incredibly difficult. Employers and internship hosts in economics-related fields rarely provide students in economics internships the opportunity to meet such a strict threshold. Likely, this unfortunate reality is due to widespread belief that "doing economics" requires a Ph.D. in economics -- and more specifically, the technical training contained within that degree program. Removing ECO 4941 from the list of courses that meets the "Required Upper-Level Coursework" requirement for the economics major would allow the department to adopt a more reasonable and attainable threshold for awarding internship credit. In fact, the department is currently beginning the process of developing a formal internship program.

Impact on Enrollment, Retention, GraduationThese is no direct impact on enrollment, retention, or graduation.

In the future, removing ECO 4941 from the economics major will likely increase the number of students that receive credit for ECO 4941.

Assessment Data ReviewEach of the 3,000-/4,000-level economics elective courses (including ECS 4110 and ECS 4111) reinforce and assess the critical thinking and communication SLOs for the economics major:

Model and analyze unfamiliar social interactions using a formal economic framework.
 Communicate effectively the concept of opportunity costs and trade offs.

Students that complete the economics major should be able apply economic methods to various social interactions, even those that they have not encountered in their economics coursework. For example, a student should be able to apply a cost-benefit type of analysis to a personal financial decision (e.g., leasing vs. buying a new car, taking out a student loan). Students should also be able to communicate the associated trade offs and identify the option supported by formal economic analysis.

Thus, the "Required Upper-Level Coursework" requirement within the economics major should include all 3,000-/4,000-level economics courses (i.e., those courses with an ECO, ECP, or ECS prefix) that are not already explicitly required for the economics major. Each of them addresses the SLOs associated with the economics major.

Coursework for the Major

The major requires 37-39 credits. Students must achieve minimum grades of C in each required foundation and economics course, including the economics electives and outside substitutes.
