Course Description This course analyzes the United States Marine Corps as the overarching case study for the advent of maneuver warfare. The value is not simply to learn what has happened in the past, but to use these lessons as the basis for making practical judgments about the present and future.

Prerequisites NSC1110 or Instructor Permission

Co-requisites None.

Rationale and Placement in Curriculum Fundamentals of Maneuver Warfare is a detailed look at broad aspects of warfare and their interactions with maneuver warfare doctrine. Specific focus is given to the United States Marine Corps as the premier maneuver warfare fighting institution. Historical influences on tactical, operational, and strategic implications of maneuver warfare practices in current and future operations are highlighted to sharpen students' analytical thinking, decision making and ultimately leadership capability. Finally, this course will prepare future Naval Officers prior to reporting to Officers Candidate School.

Course Objectives The students will complete the course with a thorough understanding of what maneuver warfare is and how its use throughout history has shaped both the United States Marine Corps as an institution as well as warfare in general. Students will be familiar with Marine Corps history, doctrine, policy and procedures. Students will have a basic level understanding of small unit tactics and naval correspondence as it affects the communication of orders. Students will be able to meet

all professional core competencies as detailed in Naval Service Training Command's course guide (Updated based on final approval from NSTC).
