**Rationale**In this major, students are required to complete 25 ours of observation in order to graduate. In the past, the students took two credits of SPA 4050, which required 20 hours of observation. They completed the remaining five hours in another class. We would like to change SPA 4050 to 3 credits and increase the observation hours to 25 so that our students can complete all of their required observation hours in one class. With the increase in observation hours, we also plan to make this class more of a Capstone integrated experience, where they draw on concepts learned from other classes.

#### PURPOSE AND OUTCOME

#### **Course Overview**

One of the most beneficial experiences you can acquire prior to selecting a career within a profession is to observe practitioners of that profession. You get to see what their day is like, what the clients are like, what their working environment is like, etc. Observations can also help you move beyond just learning relevant information for a single test within the context of a course; when you see the principles and practices that were introduced in a class actually put to use in a clinical situation, your knowledge suddenly takes on greater meaning and value.

Most universities require students to have completed 25 hours of observation before starting their clinical education (seeing patients) and require a letter from your university verifying that you have completed these hours. In order to help you get the 25 hours, we have developed this course Clinical Observation (SPA 4050), which is required of all CMS majors.

This course also is intended to allow you to begin to draw from the knowledge you've gained in other courses in the program, and see these principles implemented in practice with real clinicians and patients.

IF YOU INTEND TO DO A LIVE OBSERVATION IN A CLINIC NEAR YOU, we need a copy of your complete, current immunization record (your physician should be able to provide this). Immunizations must include the varicella vaccine, the Hepatitis series of 3 shots, and an annual TB test (or documentation from your physician that the test is contraindicated). Please note that the TB test is good for one year and you may not do any live observations if your TB test is older than one year.

Each student is required to complete 25 hours of observation by the end of the semester in which they are registered for SPA 4050. You are required to observe ASHA certified SLPs and audiologists (this means that the clinicians that you observe have their Certificate of Clinical Competency or CCCs).

- a. You must complete 10 hours of observation and submit your logs via Canvas by February 16, 2017 (at 11:59 pm Eastern). Submission of log is worth 100 points. For each day a log is late, 5 points will be deducted from your total points.
- b. The remaining 15 hours (logs) must be submitted via Canvas by April 19, 2017 (at 11:59 pm Eastern). Submission of log is worth 100 points. For each day a log is late, 5 points will be deducted from your total points.
- c. You may submit observation hours completed prior to this semester.
