**Impact on Program** The revised course changes are in the approval process and the Arts in Medicine and School of Art and Art History undergraduate programs have capacity for students in the required courses.

**Rationale for Proposed Change(s)** The proposed name change more accurately describes the certificate. The prior certificate curriculum was broader so that it could encompass other art forms (theatre, music, etc.). These curriculum changes are more specific to the visual arts discipline and allow students to more thoroughly focus on developing the skills necessary to applying the visual arts to health and wellbeing in healthcare and community settings.

**Assessment Data Review** The current program goals are as follows:

1. Recruitment/enrollment: to recruit and retain 6 undergraduate certificate students per year.
2. Program Development: to offer an undergraduate certificate curriculum in arts in medicine that prepares students to plan or develop professional careers in the field.
3. Student Learning Outcomes/Assessment: to accurately assess student learning through appropriate course and practical assessment methods.

Current SLO's are:

1. Students identify and explain historical and contemporary foundations and practices within the field of arts in healthcare.
2. Students identify and develop practical skills and professional competencies related to facilitation of the creative process and navigating healthcare environments to ensure patient safety.
3. Students articulate and appraise the scope of arts in healthcare practice in the context of related disciplines, such as the arts therapies.
4. Students describe effective research methodologies and how they are applied to their artistic discipline.
5. Students communicate effectively in verbal and written form.

**Academic Assessment Plan Changes** We would like to make the following adjustments:

PG 1: "Retain 5 undergraduate certificate students per year"

PG 2: "Advance the caliber of our students and create a feeder into the graduate program.

The certificate recognizes students' academic achievement and practical competency in the use of the visual arts to enhance individual and community health and to impact healthcare environments. Students will be introduced to theory and practice in the field of arts in health, and will develop skills for applying the visual arts to the promotion of health and wellbeing in healthcare and community settings.

Students who fulfill the requirements for the Undergraduate Certificate in Visual Arts in Medicine gain unique life experience and skills. This certificate, recognizing these special skills, can serve as a credential for developing post-baccalaureate educational pathways and meaningful career options.

**Pre-requisites:** Students applying to the Undergraduate Certificate in Visual Arts in Medicine must demonstrate a minimum intermediate level competency in the visual arts (in any medium). This proficiency should be documented through intermediate level studio coursework on an academic transcript. While this proficiency is a prerequisite of program admission, in some instances students may achieve this proficiency while earning the certificate. Prospective students may consult with the undergraduate certificate advisor to discuss options.

**Application Procedures:** Students interested in obtaining the Undergraduate Certificate in Visual Arts in Medicine should apply to the program by the end of their sophomore year. Students from any major may apply to the program, but must complete at least 50% of certificate requirements after they have been accepted into the program. The application process includes:

- Completion of the online application (please notify Ferol Carytsas by e-mail when you submit the application)
- Submission of a one-page personal statement and two letters of recommendation to the undergraduate certificate advisor
- An interview with the advisor and/or Center for Arts in Medicine director
