

<p style="text-align: center;">Minutes of the Meeting of the University Curriculum Committee October 19, 2010</p>

Bernard Mair convened the UCC at 1:30 in 226 Tigert Hall.

1. Approval of minutes of September 21, 2010 meeting.

Minutes were approved as amended to reflect that items 16 and 17 were moved to the October agenda and with an addition of an addendum explaining the results of the courses circulated by email.

2. Update from Faculty Senate.

10. Proposed revision of the Environmental Management in Agriculture and Natural Resources major, effective Summer B 2011.

Dr Turner reviewed this proposal that would modify the major to allow for completion through distance education. The proposal was approved.
