**Rationale** Students are required to achieve a score of  $\geq 75$  on the Aleks placement test and have a math background of at least the equivalent of MAC1147 to enroll in CHM2045. If the student takes CHM1025 and achieves less than a C, they must retake CHM1025 and achieve a C grade or better to enroll.

CHM2045L is not an enforceable co-req for logistical reasons and is not enforced.
