SCORS Meeting Update – Kellie Roberts

Kelly reported that many things was going on in that the committee was concerned about amount and quality of training (university wide, not pertaining to the library), just in general. In favor of OA funding if we can get funding.

Judy recapped SCORS meeting from last spring by reading a statement from SCORS to faculty senate from last spring. At the last academic deans meeting, Glover said he would give \$120,000 per year if no objections. At next faculty senate steering committee meeting Val Minson will present resolution and Nicole Steadman will state if no objections she will send forward to Dr. Glover/President Fuch/David Norton.

Dean's Report (updates) – Judy Russell

- a. Open Access Publishing Fund Policy & Procedures/Update Judy Reviewed and handed out document & gave background on how policies and procedures were derived. Specifically reviewed reasoning behind decisions on timing of when requests are to be submitted, committee had no objections to the document written as is. Christine Fruin working with the Libraries IT department to vastly improve the online submissions site. Committee agreed that the department chair should be notified if funds are awarded and work out of a process to provide reports about awards on a monthly basis.
- b. Judy distributed the UF OA Publishing Fund announcement draft. Minimal charges suggested. Suggestions to put link to policy & procedures document in the longer

announcement for faculty newsletter, graduate student list-serv, library blog and facebook accounts.

c. Open Access Review of Guidelines Judy disturbed document and reviewed it. She believes this demonstrates there is a lot of open access publishing. Wants to use survey to determine what their source of funding was.

Going to do a similar assessment with BioMed Central.

The CHORUS project will allow us to tell if OA publishing is spilling over into those fields.

Laura Spears has begun thinking about questions Judy will have her come to the next ULC meeting with questions to get input from the committee.

Judy is hoping that the data gathered will help move an open access policy forward at UF.
